**In order for the organization to issue NRA Training and/or Qualification Certificates, the Training and/or Qualification Program must first be reviewed, approved by, and registered with, the National Rifle Association's Law Enforcement Activities Division. The organization may then request and issue NRA Training and/or Qualification Certificates. Requests for certificates must be submitted using and official NRA Order Form.**

4. To foster and support the shooting sports, including the advancement of amateur competitions in marksmanship at the local, state, national, and international levels.
